STIPULATION FOR
SEALED VERDICT

It is stipulated by the parties to this case, by and through their respective attorneys, that if the jury which is now in deliberation arrives at a verdict at any time after _____.m. on this date or any ensuing date of deliberation, the verdict shall be sealed using the following procedure, pursuant to I.R.C.P. 1.931(3):



1. The verdict shall be signed by the presiding juror (or seven jurors, as the case may be), placed in an envelope, reviewed by the court for procedural irregularities, and then sealed and delivered to the court attendant.

2. The court attendant immediately shall deliver the sealed verdict to the clerk of this court, and the clerk shall open it, file it, and notify counsel for the parties of the verdict.

It is finally stipulated that when the verdict is returned in accordance with this stipulation, it shall have the same force and effect as if it were returned in open court in the manner prescribed by law.

It is finally stipulated that the polling of the jury is waived.

It is all agreed accordingly this 18th day of December, 2023.
